Memorial Homoeopathic Medical College and Hospital, East Ramkrishna Nagar, Patna, Bihar, for conducting BHMS course with student intake of 100 seats in UG (BHMS) course and 42 seats in Post Graduate Course [MD(Hom.)] in 07 Departments namely Organon of Medicine with 06 seats, Materia Medica with 06 seats, Repertory with 06 seats, Pharmacy with 06 seats, Practice of medicine with 06 seats, Paediatrics -06, Psychiatry with 06 seats for the academic year 2023-24 – reg.

G.D. Memorial Homoeopathic Medical College and Hospital is functional since 2001 and has submitted an application for permission for sanction of 100 seats in BHMS course and 42 seats in Post Graduate Course [MD(Hom.)] in 07 Departments namely Organon of Medicine with 06 seats, Materia Medica with 06 seats, Repertory with 06 seats, Pharmacy with 06 seats, Practice of medicine with 06 seats, Paediatrics -06, Psychiatry with 06 seats for the academic year 2023-24, in which the entire functional profile has been narrated. The application has been examined by Medical Assessment and Rating Board for Homoeopathy as to whether the college fulfils the Minimum Standard Requirement to be fulfilled as per the prevailing regulations under NCH Act 2020 and conducted the Inspection of college on 20.07.2023 and 21.07.2023. Accordingly, it is to inform you that inspection reports submitted by inspectors, were examined by the Medical Assessment and Rating Board and following deficiencies were noticed:

1. Only computerized central OPD data available. No any department wise manual register available.
2. In IPD only new cases details available in central computer system. No any department wise IPD manual register available.
3. IPD and OPD patient figures seems to be escalated.
4. All modern medicine consultant are on call.

College is required to follow standard guidelines in the functionality as under:

1. Case records should be well maintained in respect of case analysis, evaluation and repertorization and made available in Medical Record Room for academic purpose of students and follow up attendance of patients.
2. Case sheets should have complete demographic details and contact details of patients.
3. Diagnosis should be written in ICD 11 criteria

Considering the above shortfalls, Medical Assessment and Rating Board for Homoeopathy has decided to issue **conditional permission** to **G.D. Memorial Homoeopathic Medical College and Hospital, East Ramkrishna Nagar, Patna, Bihar, for conducting BHMS course with**

student intake of 100 seats in UG (BHMS) course and 42 seats in Post Graduate Course [MD(Hom.)] in 07 Departments namely Organon of Medicine with 06 seats, Materia Medica with 06 seats, Repertory with 06 seats, Pharmacy with 06 seats, Practice of medicine with 06 seats, Paediatrics -06, Psychiatry with 06 seats for the academic year 2023-24. The shortfalls observed in your College shall be rectified within a period of 15 days or before counselling initiates whichever is earlier and compliance report shall be submitted to the MARB, failing which the conditional permission issued will be withdrawn without further notice.

All admissions shall be made from NEET/ AIAPGET qualified candidates only. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy and the penalty as decided will be imposed in such cases. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/ UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by Medical Assessment and Rating Board.
