AND WHEREAS the founder have made over a sum of Rs. 50,000/- (Fifty thousands only) to the trustees by way of initial contribution and the trustees have agreed to become TRUSTEES and to hold and apply the said sum of Rs. 50,000/- (Fifty thousands only) and all gifts, contributions, subscriptions, donations etc. received hereinafter for public charitable purposes subject to powers and provisions contained in this deed.

AND WHEREAS, the TRUSTEES have agreed to carry out the trust herein created.

NOW THE TRUST DEED WITNESSES AS FOLLOWS

1. That the name of the trust shall be G.D. Memorial Trust.

2. **OFFICE OF THE TRUST:**

That the office of the trust shall be situated at Shankar Homeo Hall, A.N.Road, Kadamkuan, Patna-800003 and /or at such other place or places as the TRUSTEES may decide from time to time with an intimation to the authorities concern.

3. **THE AIMS AND OBJECTS OF THE TRUST:**

(A) To open, establish, and run a educational institutions Research Centres and study centers for importing education, trainings to students.

14. The Trustees shall be accountable only for such money, stocks, shares and funds, which shall actually come into their hands. A trustee shall not be answerable or accountable for neglect, default, acts or omission or Commission of the other Trustees nor of any bankers or other person with whom the trust properties or any securities may have been deposited or kept.

15. The Trustees shall not be entitled to receive any remuneration, but the trustees may reimburse themselves all expenses actually incurred by them in connection with the trust or their duties relating thereto.

16. **APPLICATION OF TRUST PROPERTY INCOME:**

It is expressly declared that no part of the trust property shall be applied for any purposes, which is not a public charitable purpose in law, and all provisions hereof shall be construed accordingly.

17. **JURISDICTION:**

(i) The trust shall be authorised to function throughout India.

(ii) Should any legal disputes, claims or litigation within the jurisdiction of the law arise, they will only be considered valid if they are lodged within the precincts of the city of Patna.

18. In case of failure of the trust for want of its object or Trust having become impossible of performance, the trustees shall move the court for applying the remaining trust fund for similar object.
