Jaganpura Patna -800 027 for continuing BHMS course with intake capacity of 100 seats and for PG with intake capacity of 42 seats in 07 subjects namely Organon of medicine with Homoeopathic Philosophy with 06 seats, Repertory with 06 seats, Homoeopathic Materia medica with 06 seats, Homoeopathic Pharmacy with 06 seats, Practice of Medicine with 06 seats, Paediatrics with 06 seats, Psychiatry with 06 seats for the academic year 2025-26 - regd.

Sir,

G.D. Memorial Homoeopathic Medical College and Hospital is functional since 2001 and has applied for permission for sanction of BHMS course with 100 seats and for PG with intake capacity of 42 seats in 07 subjects namely Organon of medicine with Homoeopathic Philosophy with 06 seats, Repertory with 06 seats, Homoeopathic Materia medica with 06 seats, Homoeopathic Pharmacy with 06 seats, Practice of Medicine with 06 seats, Paediatrics with 06 seats, Psychiatry with 06 seats for the academic year 2025-26. The College has submitted the Part I information in which the entire functional profile has been narrated. MARBH conducted Inspection on 27.05.2025 & 28.05.2025. The Medical Assessment and Rating Board has examined the College as to whether the college fulfils the Minimum Essential Standards as per the prevailing regulations under clauses 26 and 28 of the NCH Act 2020. On careful examination of the report, the Medical Assessment and Rating Board observed the following shortfalls: -

1. Teaching faculty.

- i. Deficiency of One professor in Department of Research Methodology and Biostatistics.
- ii. Principal cannot hold the position of Professor in PG department of Organon of Medicine and Homoeopathic Philosophy; it is a separate post.

2. Hospital Staff:

i. Registers in hospital department and laboratory are not maintained.

3. Miscellaneous:

- Salary of teaching staff and non-teaching staff is not as per MES 2024.
- 4. Considering the above observations during inspection, MARBH has decided to issue Conditional Permission to G.D. Memorial Homoeopathic Medical College and Hospital, East Ram Krishna Nagar, P.O. Jaganpura Patna -800027 for continuing BHMS course with intake capacity of 100 seats and for PG with intake capacity of 42 seats in 07 subjects namely Organon of medicine with Homoeopathic Philosophy with 06 seats, Repertory with 06 seats, Homoeopathic Materia medica with 06 seats, Homoeopathic Pharmacy with 06 seats, Practice

- of Medicine with 06 seats, Paediatrics with 06 seats, Psychiatry with 06 seats for the academic year 2025-26, on the basis of following conditions:-
- The institute will rectify all the deficiencies mentioned in point no. 2 and 3 of the letter within a period of one month and the compliance report shall be submitted for verification to the MARBH, failing which permission for the academic year 2025-26 may be withdrawn.
- 5. All admissions shall be made from NEET/ AIAPGET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course and M.D.(Hom) course shall be treated as All India Quota. Counselling for seats under All India Quota shall be conducted by the Central Government and counselling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT designated by Central Government. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Govt. for All India Quota or the student admitted thereunder.
- 6. The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/ AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board.
