Sir,

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, under NCH Act 2020. As per section 59 (2) of NCH Act, 2020, following has been stated:

"Notwithstanding the repeal of the Homoeopathy Central Council Act 1973, the educational and medical standards, requirements and other provisions of the Homoeopathy Central Council Act, 1973 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder: Provided that anything done or any action taken as regards the educational and medical standards and requirements under the enactment under repeal and the rules and regulations made thereunder shall be deemed to have been done or taken under the corresponding provision of this Act and shall continue in force accordingly unless and until superseded by anything or by any action taken under this Act".

As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college in Part-1 proforma were examined by the Medical Assessment and Rating Board.

2. On careful consideration of the report, the Medical Assessment and Rating Board has arrived at the following conclusion:-

That the applicant has set up a Homoeopathic Medical College with the component of staff, infrastructure, equipment and instruments and other facilities where as the College has to take certain time bound steps to implement Minimum Standard Requirements of the Homoeopathy College and attached Hospital as prescribed by the National Commission for Homoeopathy for conducting BHMS course in Homoeopathy.

A. Teaching Faculty:

1. <u>For UG course</u>: the College has provided list of 55 full time teachers out of which 51 are eligible.

Discrepancies in engagement of teachers may be rectified or justified on the basis of valid grounds, rules & regulations within 3 months :

- i. Dr. Suresh Prassad, Professor (On contract) Date of birth is 1.7.52. Age exceeding 67 years.
- ii. Dr. Mukul Kumar Sahni, Professor (On contract) Date of birth is 1.1.54. Age exceeding 67 years.
- iii. Dr. Dukh Haran Prassad, Professor (On contract) Date of birth is 2.1.54. Age exceeding 67 years.
- iv. Dr. NandJee, Reader (BHMS 2003) Date of birth is 22.7.71 and joined as lecturer on 1.10.11. Age exceeding 40 years at the time of joining as lecturer.
- 2. <u>For PG course</u>: College has provided list of 33 full time teachers out of which 28 are eligible.
- 3. Discrepancies in engagement of teachers may be rectified or justified on the basis of valid grounds, rules & regulations within 3 months:
 - i. Dr. Ramjee Singh, Professor (On contract) Date of birth is 1.7.52. Age exceeding 67 years.
 - ii. Dr. Mridul Kumar Sahani, Professor (on contract) Date of birth is 17.9.52. Age exceeding 67 years.
 - iii. Dr. Kameshwar Prassad Pandey, Professor (On contract) Date of birth is 20.8.51. Age exceeding 67 years.
 - iv. Dr. Nilam Kumari Sahni, Professor (MD Pediatrics 2004) Date of birth is 25.4.59 and joined on 1.11.07. Age exceeding 40 years at the time of joining as lecturer.
 - v. Dr. Sunil Kumar Rai, Reader (BHMS 2002) Joined as lecturer on 18.9.08 and date of birth is 2.5.68. Age exceeding 40 years at the time of joining as lecturer.
- 4. The College has 02 Guest faculties available (required 12).
- 5. The College has provided list of 09 part time teachers of Modern Medicine out of which 08 are eligible as 01 consultant surgeon Md Tarique Anwar is also available in full time faculty so cannot be considered in both.
- B. **Miscellaneous:** EPF/PF /ESI deductions of teachers, non teaching staff & hospital staff Deducted for 63 members only. Also Form-16 of teachers, non teaching staff & hospital staff- not provided by the college.
- C. Website: https://www.gdmhmch.com is functioning but student's data of 2017-18, 2018-19 and 2020-21 not updated as checked on 28.9.2021.

3. After considering the provisions of section 12C (1) of Homoeopathy Central Council Act, 1973 and HCC (MSR) Regulations, 2013, permission of the Medical Assessment and Rating Board is issued to G.D. Memorial Homoeopathic Medical College & Hospital, Patna, Bihar for 100 seats in undergraduate course (B.H.M.S.) and post graduation course with 42 seats namely Organon, Materia Medica, Practice of Medicine, Repertory, Pharmacy, and Psychiatrics with six (06) seats in each subject and Pediatrics with five (05) seats subject to availability of Guides as per Homeopathy (Post Graduate Degree Course) M.D(Hom) Regulations, 1989 as amended upto 2016 in the concerned subject for the academic year 2021-22. The College Principal is directed to

fulfill the deficiencies within three months and an affidavit in this regard may be submitted to the Medical Assessment Board within a period of one week.

4. All admissions in Under Graduate and Post graduate course shall be through NEET/AIAPGET only. It is further informed that, minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India quota. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State / UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of that State / UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted thereunder.

5. The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board as per rules.

6. The college has to comply with the full requirements of Minimum Standard Requirement Regulations, 2013 for conducting the course. All deficiencies observed and mentioned above which affects the performance of the academic Institution, through which College fails to fulfill the statutory requirements, has to be rectified within three months time from issue of this permission letter. Compliance report shall be submitted by the college to Medical Assessment and Rating Board accordingly. Subsequently, the Board shall verify the compliance well in time and may conduct Online/Physical inspection for verification of compliance as per the HCC (MSR) Regulation, 2013 and will consider admissions for the academic year 2022-23.
