Memorial Homoeopathic Medical College and Hospital, East Ramkrishna Nagar, Patna, Bihar with student intake of; 100 seats in UG (BHMS) course and 42 seats in Post Graduate Course [MD(Hom.)] in 07 Departments namely Organon of Medicine with 06 seats, Materia Medica with 06 seats, Repertory with 06 seats, Pharmacy with 06 seats, Practice of medicine with 06 seats, Paediatrics -06, Psychiatry with 06 seats for the academic year 2022-23- reg.

Sir/Madam,

With reference to the above cited subject, and letter in reference above, the undersigned is directed by the competent authority to convey as under:

"The college submission of the appeal has been carefully examined by the Commission and observations are as under:

- 1. Commission observed that the Biometric attendance of staff (hospital, teaching and non-teaching) recorded without ID of the teaching, hospital and non-teaching staff, arrival and departure time which serves no purpose. Designation of staff is not given in manual register & therefore cannot be considered for verification. Also Biometric attendance of hospital staff/P.G. students provided by college does not seem genuine as it does not reflect any weekly off and seems forged. Therefore regular attendance of staff could not be ascertained due to lack of documents.
- Aquittance register provided by the college does not have signature of concerned staff.
- Aquittance register provided by the conege does not have significance or control of the property maintained with details such as Patient's name, duration of medicine prescribed, and repetition. Moreover, the genuinity of the register submitted to the committee is doubtful as the pattern of record of dispensing does not seem actual rather stereotyped.

4. At time of inspection no interns were present in hospital. Also CCTV footage submitted by college does not show OPD/IPD area. Hence genuine presence of interns could not be ascertained in the hospital.

5. College has provided Logbook, case diary, seminar presentations; clinical meeting details but is not maintained in a proper way. Also it was learnt from PG students that they have been allowed to come occasionally by the college, regular attendance of students is also not maintained. Biometric attendance of P.G. students provided without arrival and departure time. Therefore regular attendance of P.G. students could not be ascertained

## Overall observations:

- 1. Based on the submission made by Principal, G.D. Memorial Homoeopathic Medical College and Hospital, East Ramkrishna Nagar, Patna, Bihar on 08.12.2022, the documents have been carefully examined as per the provisions of the Homoeopathy Central Council (Minimum Standards Requirement of Homoeopathic Colleges and attached Hospitals) Regulations, 2013 and Homoeopathy (Post Graduate Degree Course) M.D. (Hom.) Regulations, 1989 amended from time to time and it is observed that proper functioning of the hospital and presence of PG students, and interns could not be established.
- 2. Now, THEREFORE, the Commission has decided to issue permission for UG (BHMS) course 50 seats (reduced from 100) and denial of Post Graduate Course [MD(Hom.)] in all 42 seats in 07 Departments namely Organon of Medicine with 06 seats, Materia Medica with 06 seats, Repertory with 06 seats, Pharmacy with 06 seats, Practice of medicine with 06 seats, Paediatrics -06, Psychiatry with 06 seats for the academic session 2022-23.
- 3. If aggrieved by the decision as communicated above, the applicant may further make a second appeal to the Central Government within 7 days of issue of this decision as per NCH Act 2020 Sub-section (6) of Section "9".
